NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT 2001

This notice is given by Calima Energy Limited (**Calima** or the **Company**) in relation to the issue of 2,000,000 fully paid ordinary shares (**Shares**) as detailed in this Appendix 3B.
